SECTION 4: FIRST AID MEASURES

4.1. Description of first aid measures

General information

Remove affected person from source of contamination. NOTE! Effects may be delayed. Keep affected person under observation. Get medical attention. CAUTION! First aid personnel must be aware of own risk during rescue! Move the exposed person to fresh air at once. NOTE! Keep affected person away from heat, sparks and flames! 4.2. Most important symptoms and effects, both acute and delayed

General information

Inhalation

In case of overexposure, organic solvents may depress the central nervous system causing dizziness and intoxication, and at very high concentrations unconsciousness and death.
